




Product Images For Claudin 5 Polyclonal Antibody



WB analysis of VERO cell lysate using RA1081 Claudin 5 antibody. The lane on the left was treated with blocking peptide.



Immunofluorescent analysis of Claudin 5 in A549 cells. Samples were fixed with paraformaldehyde, permeabilized with 0.1% saponin, blocked with 10% serum (45 min, 37°C) incubated with Claudin 5 polyclonal antibody (Product # RA1081) using a dilution of 1:400 (1 hr, 37°C), and followed by goat anti-rabbit IgG Alexa Fluor 594 at a dilution of 1:600.



Immunohistochemistry analysis of paraffin-embedded Claudin 5 in human colon tissue sections. Antigen retrieval was performed using citrate buffer. Samples were blocked with blocking buffer (1.5 hr, 22°C), incubated with Claudin 5 polyclonal antibody (Product # RA1081) using a dilution of 1:100 (1.5 hr, 22°C), followed by HRP conjugated goat anti-rabbit.
