

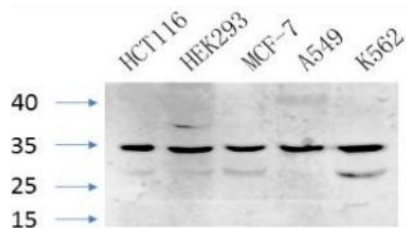

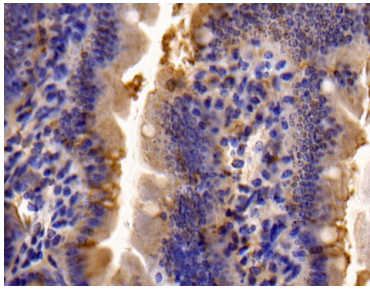

Western Blot analysis of various cells using primary antibody diluted at 1:1000(4°C overnight) Secondary antibody:GoatAnti-rabbit IgG IRDye 800(diluted at 1:5000, 25°C 1hour).Cell lysate was extracted by Minuten Plasma MembraneProtein Isolation and Cell Fractionation Kit(SM-005 Inventbiotech)



Immunohistochemistry analysis of C7 in paraffin-embedded Mouse Small intestine tissue. Samples were incubated with polyclonal antibody (Product # RA1097) at a dilution of 30 $\mu\text{g}/\text{mL}$, followed by HRP-Linked Caprine Anti-Rabbit IgG using a dilution of 2 $\mu\text{g}/\text{mL}$.
